We accept cash, checks (made payable to **SilverJax Cheer &Tumble**, as well as MasterCard and Visa. **SilverJax Cheer &Tumble** also offers an automatic tuition payment plan. If there is **NO** credit/debit card on Reg. form, I understand my tuition is due on the **FIRSTY DAY OF EACH MONTH**.
